

**San Jacinto Title I Parent Engagement Plan**

**PART I. General Expectations**

San Jacinto agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

- C. that parents are encouraged to be actively engaged in their child's education and school;
- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

**PART II.** Description of how San Jacinto will implement the required components of the campus Title I Parent Engagement Plan.

1. San Jacinto will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
  - Parents will be invited via a note sent home in English and Spanish. Call outs will be made to remind parents. Meetings will be hosted at the school with childcare for easy accessibility. Title I information will be given at the beginning of the meeting to educate parents on what it entails.

2. San Jacinto will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
  - Teacher and school staff will select parents; training will be provided during the first committee meeting and translation services will be available.
  - Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
  - Staff support will take place during the first committee meeting.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. San Jacinto will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Title I information will be provided at our back to school night in English and in Spanish.

4. San Jacinto will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Title I, Part A information will be provided at our back to school night in English and Spanish.

5. San Jacinto will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Parents Involvement meetings will be held on a monthly basis to discuss decisions about the education of their children. The school will respond to any suggestions as soon as practically possible. Interpreter services will be provided.

6. San Jacinto will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Information will be made available online and the instructions will be mailed in a letter to parents. The letter will be in English and Spanish. The computer lab will be open for parents to access a computer on campus. Staff will assist with any questions.

7. San Jacinto will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- How to begin the process of becoming an ACE Student.

8. San Jacinto will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Math Game Night
- Reading Under the Stars
- Discovery Center Night
- Skyward Parent Training
- Parenting Partners
- How to Survive Kindergarten and Beyond
- Book fair/Back to School Night/Tailgate Party

9. San Jacinto will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Social Worker will train staff on implementation and coordination of parent programs based on needs identified throughout the school year.

10. San Jacinto will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Attend Head Start graduation and send letters to Region 16 programs to invite students to our pre-k program. Parents of current students will receive information about younger siblings participating in the preschool program.

11. San Jacinto will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Provide and interpreter at meetings where a reasonable extent of parents speak a language other than English.

### **PART III. Discretionary Components of the San Jacinto Title I Parent Engagement Plan**

San Jacinto may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.

- Adopting and implementing model approaches aimed at improving parent engagement.
- Establishing a campus Parent Engagement Advisory Council to provide advice on all matters related to parental engagement in Title I, Part A programs.
- Developing appropriate roles for community-based organizations and businesses, including faith-based organizations, in parental engagement activities.
- Providing other reasonable support for parental engagement activities under section 1118 as parents may request.
